TERMS

All soft drinks invoices are due and payable within 30 days from delivery. All beer invoices are due and payable in 7 days as mandated by state law. An additional service charge will accrue on any balance not paid within our normal 30 day payment period. An account with a balance older than 30 days is automatically cash on delivery (C.O.D.). An account with a balance beyond 90 days is automatically cut-off from further deliveries.

The business owner agrees to place machine in his place of business where it may be conveniently used by the public and/or his employees and agrees that said machine shall be used to dispense only those products manufactured or distributed by the company during the term hereof unless otherwise noted and agreed upon on the front of this document.

The term of this agreement shall be indefinite, commencing as of the date of signing and shall continue thereafter until terminated. This agreement may be terminated by either party without notice at any time.

The business owner shall use reasonable care in safeguarding said machine from loss or damage. The business owner shall be responsible for any property taxes assessed on said machine. The Company shall bear the expense of maintenance and repairs except those necessitated by negligence unless said machine is purchased by business owner.

No term or condition stated herein may be changed except by written consent of Lehrkind's Inc.
